Request the Board approve an Ordinance entitled “AN ORDINANCE GRANTING A SPECIAL USE PERMIT TO ALLOW FOR THE CONTINUED RETAIL SALE OF PACKAGED ALCOHOLIC BEVERAGES AT 13 EAST IRVING PARK ROAD.” This Ordinance is being presented for first reading and posting.

This Ordinance authorizes the sale of packaged alcoholic beverages in an existing retail store, within a C-2 Commercial District, located at 13 E Irving Park Road.

This Resolution renews the agreement between the Village and School District U-46 offering School Resource Officers at Canton and Tefft Middle Schools and Streamwood High School for the 2026-2027 school year.

Request the Board approve a Resolution entitled “A RESOLUTION APPROVING AND AUTHORIZING THE EXECUTION OF AN AMENDMENT TO THE AGREEMENT WITH GROOT, INC. FOR THE COLLECTION AND DISPOSAL OF GARBAGE, REFUSE, SOLID AND YARD WASTE, AND RECYCLABLES.”

This Resolution authorizes the renewal of the contract for waste collection and recycling services offered by Groot, Inc. The contract will increase rates \$1.44 on July 1, 2026, with 3.75% increases for each subsequent year. The contract runs from 2026-2031.
